### Content: \*Grant Updates

## • Community Foundation Grant – Ozone Shed Cover

• Moving forward with GHD. CCSD is satisfied with the design that has been modified to fit the existing footprint. Dane followed up to get the engineers' stamp of approval.

### • State Waterboards Grant - Influent Well

• Dane is hopeful the package updates will be completed within the next couple of weeks. The cost for the well replacement with screen has been estimated to cost \$1.2 million.

### • DWR Grant - Infiltration Repairs, Ozone Shed Cover & Solar Array

• Dane has been working with the lead engineer to complete the design review which is almost finalized. The changes will add 15-20% to the cost to the shed cover for the revised cover posts placement.

### \*Discuss & Vote - Ozone Cover - Design/Cost Changes

- The changes that were made to the ozone cover posts placement will allow for the solar panels to be placed on top. These changes will add up to 20% of the original cost estimate.
- ✓ Joe motioned to approve the increase and suggested taking the funds out of the Capital Reserves bank account. Sherrie seconded and the Ozone Cover Design Cost Changes was passed unanimously.

### \*Review Ozone Replacement Tube Purchase - \$3,458.81

• Replacement tubes were purchased to have on hand in case the current ozone tubes burn out. These tubes change oxygen into ozone. The Board was made aware of this cost during the 2020-21 budget review and approval.

### **Discuss Electrical Generation Options – Flower Turbines**

• There has been no response from Flower Turbines since Dane contacted the company. He has called and sent several emails. Although the Board likes the Flower Turbine design it was suggested to look at other options and turbine companies.

### \*Discuss Treatment Plant & Moratorium Mitigation Plan

- The BOD Biological/Chemical Oxygen Demand in the treatment plant water has gone down. This is good news as there is no opportunity to add sewer capacity until these levels stay low through the summer. If the levels remain low for several months, then the infiltration issue will be the main problem holding back lifting the moratorium.
- It will still be a full year until the moratorium could be lifted.
